HARVEY BEEF GATE 2 PLATE CHALLENGE RULES & REGULATIONS



CATTLE

- Each team will contain only steers. No heifers will be accepted into the 2024 Harvey Beef Gate 2 Plate Challenge. A team will consist of a minimum of three (3) steers, up to a maximum of four (4) steers. Points from the three (3) best performing steers will be combined to identify the overall winning team.

Competitors retain ownership of the cattle throughout the Harvey Beef Gate 2 Plate Challenge and receive proceeds for all animals entered, after processing through the Coles supply chain.

- It is the owners' responsibility to select cattle at an appropriate entry weight, condition, and age to ensure they will meet the processors specifications. To assist with your selections the suggested entry weight is 340 - 380 kg. The processor specifications are:

HGP FREE MSA YEARLING CATTLE SPECIFICATION GRID	
Type	British and European Breeds and their crosses
Carcass Weight (dressed)	210-310kg
Fat	4-17mm
Dentition	0-2 teeth
Cattle must be HGP (hormone growth promotant) FREE	

- The cattle you enter must:
 - Be Owner Bred, however schools may enter a team of non-owner bred cattle for education purposes although will be ineligible to win any Harvey Beef Gate 2 Plate Challenge Prizes.
 - Not currently or at any time have had HGP's (hormone growth promotants) implanted.
 - Have had both testicles completely removed. Stags will not be accepted.
 - Have no unhealed wounds resulting from castration and show no excessive signs of secondary characteristics because of being late cut.
 - Be either polled or dehorned with no regrowth that has sharp edges or is more than 10cm. Animals that have been dehorned must be healed at the time of induction.

All challenge animals will be assessed by 5 independent industry scrutineers, at the Mount Barker Regional Saleyards. Any animal deemed to be of questionable suitability, will be withdrawn from the challenge. The decision will be made on a majority basis and their decision will be final.

- Pink Eye Infections – Animals presented for the challenge should be free of pink eye infection. A minor case of pink eye is acceptable provided that it has been treated and acceptance confirmed with Gate 2 Plate Challenge committee prior to delivery to the Mount Barker Regional Saleyards. All animals must be deemed fit to travel.
- If any animal in the challenge requires, on Veterinary advice, antibiotic, or other treatment to ensure its welfare throughout the duration of the competition, the cost of those treatments will be removed from the final value of the carcass paid to the owner. In extenuating circumstances, appropriate treatment may include euthanasia. Deceased animals may be subject to post-mortem assessment, upon veterinary discretion.
- Throughout the challenge if, on Veterinary advice, an animal must be removed from the competition for any reason, it is the responsibility of the owner to collect the animal and remove it from the feedlot as soon as possible.
- If at feedlot entry, on Feedlot Managers advice, any animal is judged to be not fit for feedlot finishing that animal will be withdrawn from the challenge. It is the responsibility of the owner to collect the animal and remove it from the saleyards or feedlot, as soon as possible.
- If at the point of final weighing, on Stock Agents' advice, any animal is not deemed fit for slaughter, that animal will be withdrawn from the challenge. It is the responsibility of the owner to collect the animal and remove it from the feedlot as soon as possible.

LOGISTICS

- Animals must arrive at the Mount Barker Regional Saleyards at the following times.
Cattle arriving out of these time zones will NOT be accepted.

DATE	CATTLE MUST ARRIVE BETWEEN
Wednesday 3 rd January 2024	8am and 5pm
Thursday 4 th January 2024	6am and 10am

- The owner is responsible for the organisation and cost of transporting the animals to the Mount Barker Regional Saleyards.
- All cattle movements on the NLIS database will be completed by saleyard staff. Cattle will be transferred onto the saleyard PIC and then onto the Gate 2 Plate Challenge PIC on transfer to the feedlot.

On arrival at the saleyards, cattle must:

- Fulfil all the usual requirements and regulations of cattle arriving at Mount Barker Regional Saleyards.
 - ~ Cattle **must have** a functional NLIS tag.
 - ~ Cattle **must be** accompanied by a correctly completed National Vendor Declaration (NVD, Version 0720).
 - ~ Cattle **must** abide by all fit to load requirements and regulations.
 - ~ Cattle also **must have** management ear tags provided by the Harvey Beef Gate 2 Plate Challenge.

Animals not fulfilling these requirements will be unable to commence the challenge. A yard fee, per day, will be charged to the owner until the animal is removed from the saleyards.

- The NVD must be completed with the following information:

Incorrectly completed NVD's will incur a points penalty for that team. For more information on NVD's and how to complete correctly go to <https://www.integritysystems.com.au/on-farm-assurance/national-vendor-declaration-nvd/nvd-0720-changes/>

- Be in an appropriate state of health to commence and complete the competition as judged by an onsite veterinary officer. Owners of animals which, on veterinary advice, are not deemed fit to commence or complete the duration of the challenge will be notified. It will be the responsibility of the owner to remove the animal from the Mount Barker Regional Saleyards as soon as possible. A yard fee per day will be charged for these animals.
- Be tagged with the management ear tags provided by the Harvey Beef Gate 2 Plate Challenge before arrival at the saleyards, one in each ear. (The tags will be posted to you after entries close). Cattle that are not correctly tagged with the challenge tags on arrival at the saleyards will have points deducted.

All other management tags must be removed from the animals' ears.

LOGISTICS CONTINUED

- Cattle will remain at the Mount Barker Regional Saleyards on hay/silage and water for up to five days after which they will be trucked to Willyung Farms Feedlot to begin the grain finishing period.
- The cattle will be on feed for approximately 85 days. Please note that whilst it is our intention to keep to the days on feed stated above, they may be subject to slight changes to work in with feedlot, transport and processor logistics.
- The ration will be approved by an accredited nutritionist as being suitable for growing and preparing cattle to meet the destination market specifications.

TREATMENTS

All cattle will receive the following treatments on arrival at Willyung Farms Feedlot: Dectomax V Injectable (Zoetis), Rhinoguard (Zoetis), Bovishield MH-1 (Zoetis), Websters 5:1 Vaccine with B12 (Virbac), Multimin Evolution (Virbac), Fly Treatment (Nutrien). It is the owners' responsibility to administer any other vaccinations which they think are necessary to assist in maintaining the full health of their animals whilst on the feedlot. Cattle that require treatment for health issues on the feedlot quickly become unprofitable through reduced rate of gain as well as the cost of treatment. Note that points for the feedlot section are based on profitability.

No competitors are to arrive unannounced at Willyung Farms Feedlot. Cattle can be viewed at the field day. Competitors arriving unannounced at the feedlot will have points deducted and will be removed from the competition.

The remaining entry fee of \$2,360.00 inc GST, per team of 4, and \$1,714.30 inc GST, per team of 3, will be deducted from the proceeds of the cattle after processing. The Entry Fee is non-refundable and covers costs associated with grain finishing cattle in a normal commercial situation and includes feedlot costs, transport, management tags and induction medications, and 2 x Dinner Tickets per entry.

Elders will finance of \$2,360.00 inc GST, per team of 4, and \$1,714.30 inc GST, per team of 3, being the remaining entry fee, at no cost to challenge entrants. This will then be deducted from proceeds paid to challenge entrants, after the cattle have been processed.

If the entrant is not already a client of Elders, a Trading Account Application Form must be completed, and bank account details provided for payments to be made.

It is an agreed upon condition of entry that Elders will deduct of \$2,360.00 inc GST, per team of 4, and \$1,714.30 inc GST, per team of 3, from proceeds once cattle are processed, being the remainder of the entry fee.

PAYMENTS

1. The value of the carcasses paid will be based on commercial pricing at the time of processing.
2. Payments to participants for the value of carcasses will be processed by Elders.
3. Elders will deduct of \$2,360.00 inc GST, per team of 4, and \$1,714.30 inc GST, per team of 3, from cattle proceeds, being the remainder of the entry fee, before payment to vendor.
4. Participants must ensure they provide the correct bank details. It is the participant's responsibility to notify Elders immediately if their bank account details change between submitting the entry form and receiving the payment.
5. If you are not a client of Elders the relevant paperwork will be forwarded to you.
6. The amount received by participants will be the value of the processed cattle at the end of the competition minus:
 - Costs of any additional treatments (e.g., antibiotics) deemed necessary, on veterinary advice, to maintain the welfare of the animals during the competition.
 - Cost of the Harvey Beef Gate 2 Plate Challenge booklet which contains the detailed feedback information about animal performance.
 - Agent Commission
 - Transport Insurance
 - Abattoir Costs
 - Levies
 - Any other associated costs
